which time it would be sold at auction. From the money arising from the sale, he gave \$16 each to his sons John, Andrew, Thomas, Jacob, George Washington, and William, and daughter Margaret Biggart. He gave his = wife

Elinor one-third of the proceeds, she to dispose of them at her death = as she

thought proper. He gave the remaining two-thirds to his other children Joseph Elliot Gibson, Agness Gibson. He gave to Joseph Elliot Gibson = \$100

before any division was made, as well as a bed, and gave beds and = bedding to

daughters Agness and Mary Gibson. He appointed William Gibson and = Joseph

Elliot Gibson executors. The will was witnessed by Robert Thomson and Nathaniel Crosby; they acknowledged their signatures in court on 4 = November

testamentary and ordered to present an inventory of his estate.=20

Steve Kennedy, a descendant of Isabel (Gibson) Kennedy, received = information

from another Kennedy descendant, Jim Barkley. He had a typed history of =

the

Buchanan family written by Ralph W. Hines in 1935, entitled "The Googy Records." This included a sketch of the Buchanan and Gibson families. = It says:

David Buchanan emigrated to America from Ireland in the latter half of = the

17th century. He died August 15, 1799. He was married to Margaret = Boggs,

January 23, 1770, who died September 2, 1819. To this union four = children

were born, (I) Alexander, (II) John, (III) Margaret Cochran, (IV) Jane.

(IV) Jane was born March 9, 1779 and died December 14, 1856. She was = married

to Thomas Gibson, who was born February 28, 1772 and died June 5, 1866. = To

this union were born the following children, (George, David, Elizabeth, Isabel, Jane, Tabitha, and Margaret.)

This sketch seems to have been based on old family records, since the = dates

are not found elsewhere and must come from such a source. No place = names are

given, but David Buchanan of Londonderry Township, Chester County, Pennsylvania, died testate in 1799, bequeathing property (by will dated = 16

Aug. 1798, proved 1 October 1799, recorded in Will Book K, vol. 10, pp. 139-141) to a wife Margaret and children Alexander, John, and Jane. No daughter Margaret Cochran is named; the name Cochran was common in Londonderry, but she could have died without issue by that date. = Presumably

David and Margaret are buried in Faggs Manor Presbyterian Church = Cemetery.

Pennsylvania marriage licenses show one issued to David Buchanan and Margaret Boggs, 23 January 1770.

In the Chester County tax lists, David Buchanan first appears in 1760 = in

West Fallowfield, and was there in 1762 and 1763. As he was not named a "freeman," meaning a single adult male, he must have been married at = that

time. He appears in Londonderry in 1766, with 100 acres, and on = subsequent

lists is in that town. In 1767 and 1771 he was described as a = blacksmith.

In a letter to Mrs. David L. Ostfeld, of 6651 N. Mendota Ave., Chicago, = IL

60646, dated 30 Sept. 1984, Evylon Buchanan, of 3452 Lime Ave., Long = Beach.

CA 90807, a descendant of David's son Alexander, writes "the story = handed

down thru generations is that Alexander and his brother came to = America,

were separated at the dock and never saw each other again. From this we might guess they came as 'Indentured Servants.'" This story more likely would refer to Alexander's father David.

No other Buchanans seem to have lived nearby, so such a story seems plausible. However, it does seem possible that David had children by = his

first wife and did not mention them in his will. The records of Faggs = Manor

Presbyterian Church, or rather of its minister John E. Finley, mention = a

marriage of George Luckie and Elizabeth Buchanan, on 9 April 1783, and = one

of David Buchanan and Eliz. Ried, 1 Mar. 1792. Mary, daughter of David = and

Eliza Buchanan, was baptized 31 March 1793.

Margaret Boggs is harder to figure out. The most likely person to be = her

father, William Boggs, who died in 1790 in West Fallowfield, had a = daughter

Margaret, but his will proves that she was married to James Johnston. = If she

was a widow when she married, no suitable Boggs husband can yet be = found.

The IGI has a record (source 1553754) of a John Buchanan, born 1778, of Londonderry, Chester County, Pa., son of David Buchanan and Margaret Merrick, so this needs to be investigated.
